Public Knowledge and Perceptions of COVID-19 293

Early public knowledge about COVID-19 and intended adher ence to recommendations were high, but distrust of government and concern about mixed messaging and information overload contributed to "compliance fatigue" and vaccine hesitancy.

Effectiveness of Physical Exercise in Older Adults With Depression 302

Both antidepressant treatments (AT) and physical exercise (PE) are capable of reducing depressive symptomatology among persons aged >65 years, but AT was superior in the medium term, despite giving rise to a greater number of adverse effects.

Health-Related Social Needs Screening 310

In a qualitative study of Michigan FQHCs, authors found statewide programmatic requirements and internal leadership decisions drove variation in social needs screening practices with great value placed on the role of community health workers.

Primary Care and Older People's Outcomes 318

A study in 2 developed countries found minimal variability in older patients' function, QOL, and unplanned hospitalizations associated with characteristics of GPs or practices, and higher admissions for larger practices and those with practice nurses.

Change in Diabetes Costs in China 332

The complexity and costs of drug regimens prescribed to Chinese patients with diabetes are gradually decreasing, according to an analysis of electronic insurance data in Beijing.

Burnout in Underrepresented Minority Family Physicians 342

Family physicians underrepresented in medicine were significantly less likely than their non-underrepresented counterparts to report emotional exhaustion and depersonalization.

Primary Care's Role in Vaccination and COVID-19 Immunization 351

Primary care practices provide one-half of the routine vaccines in the United States, representing a ready-made distribution system for COVID-19 vaccines.

Lessons From Behavioral Health Integration 356

The integration of social care into primary care can learn from lessons developed over 2 decades integrating behavioral health care into primary care as we seek to further improve the health of both patients and communities.
