AMERICAN BOARD OF FAMILY MEDICINE ELECTS NEW OFFICERS AND BOARD MEMBERS

The new ABFM officers will each serve a 1-year term:



Dr Baxley is a Professor of Family Medicine and Senior Associate Dean for Academic Affairs at the Brody School of Medicine at East Carolina University, where she has served since 2012. Before joining the faculty at Brody, she spent 18 years at the University of South Carolina School of Medicine, serving as Residency Director, and later as Chair, of the Department of Family and Preventive Medicine. Dr Baxley will serve the ABFM on the Executive Committee, the Bylaws Committee, the Credentials Committee, the Examination Committee, the Audit/Finance Committee, the Research & Development Committee as its Chair, and the Certification Committee.

Dr Kruse is a Professor in both the Department of Family & Community Medicine and Medical Education as well as Dean and Provost of the SIU School of



Medicine. Prior to this, Dr Kruse spent 9 years as the Executive Director of the Quincy Family Medicine Programs, and 19 years on the faculty of the Quincy Family Practice Residency Program, serving as Assistant Program Director for 9 years and as Program Director for 12 years. Dr

Kruse will serve the ABFM on the Executive Committee, the Bylaws Committee, the Operations Committee as its Chair, the Examination Committee, the Audit/Finance Committee, the Research & Development Committee, and the Communications/Publications Committee.



Dr Douglas is Chair of the Department of Family Medicine at the University of Connecticut School of Medicine and Saint Francis Hospital and Medical Center. He previously served as Chairman of the Department of Family and Community Medicine and Associate Dean for Diversity and Inclusion at

Dr Gravel is a Professor of Family Medicine & Community Health at the University of Massachusetts Medical School. COMMITTEE TACKLES COMMUNITY PRECEPTOR SHORTAGE

Primary care clerkships are struggling to obtain and retain quality clinical training sites. Clinical training at these sites gives medical, nurse practitioner, and physician assistant students hands-on opportunities with patients in real-world settings. A joint survey conducted by the American Association of Colleges of Nursing (AACN), the American Association of Colleges of Osteopathic Medicine (AACOM), the Association of American Medical Colleges (AAMC), and the Physician Assistant Education Association (PAEA), found that all 4 disciplines are experiencing increasing difficulty obtaining clinical training sites.¹

- At least 80% of respondents in each discipline felt concern regarding the adequacy of the number of clinical training sites
- More than 70% of respondents in each discipline felt that developing new sites was more difficult in 2013 than it had been 2 years before
- The key factors influencing the ability to develop new sites were security and legal requirements and training and orientation of preceptors
- Despite observed growth in schools/programs and enrollment over the last decade, the majority of respondents indicated that the number of available sites and competition for sites have an impact on enrollment capacity in their programs.¹
