Older Patients With Dizziness 100

This 10-year study of older primary care patients found that the prognosis and survival rate for patients with dizziness primarily caused by peripheral vestibular disease was better than for those with cardiovascular disease.

Engaging Patients in Advance Care Planning in Outpatient Settings 110

Patient engagement in advance care planning increased after use of an online program at home.

Predicting Opioid Use Following Discharge After Cesarean Delivery 118

Anticoagulants' Safety and Effectiveness in General Practice 131

This observational study of oral anticoagulants in French primary care practices observed a lower incidence of overall bleeding with Vitamin K antagonists (VKA) after 1 year, but a 2-times higher incidence of death in the VKA group compared to direct oral anticoagulants (DOACs).
